Booking Conditions

Please note that it is essential to read and understand the conditions of booking below. Please ensure you have read and understood the itinerary and style of the trip/s you are booking. Women's Own Adventure accepts bookings subject to the following conditions:

validity

The prices listed are based on the costs at the time of quoting. Women's Own Adventure reserves the right to alter these prices at any time. All information is accurate to the best of our knowledge at the time of quoting, but please note that changes to our trips (which can be significant) can and do occur. Women's Own Adventure will make every effort to keep you informed of any changes, but cannot be held liable for any alterations made to the published itineraries.

cancellation by the traveller

Loss of monies paid applies to all cancelled reservations. The date of trip cancellation is the date on which the written cancellation is received by Women's Own Adventure. The loss of monies paid is as follows, per person:

- 60 days or more prior to trip departure - Loss of deposit
- Between 30 and 59 days prior to trip departure - 50% of total booking cost or loss of deposit; whichever is the greater
- Less than 30 days prior to departure - 100% of total booking cost

No refunds will be made if you voluntarily leave a trip for any reason after the trip has begun. Refunds will be at the discretion of Women's Own Adventure if you are involuntarily forced to leave a trip for any reason. No refunds will be made for any accommodation, transport, sightseeing, meals or services not utilised. Please note that these conditions apply to land content only. Different fees may apply to airline tickets. You are strongly advised to take out cancellation insurance at the time of booking which will cover cancellation penalties in certain circumstances (Note: such insurance will not cover a change of mind).

cancellation by Women's Own Adventure

Women's Own Adventure reserves the right to cancel any trip before it is run. Women's Own Adventure reserves the right to cancel any trip at any time prior to departure due to terrorism, natural disasters, political instability or other external events which make it unviable for Women's Own Adventure to operate our planned schedule. If Women's Own Adventure cancels a group adventure trip more than 14 days prior to departure on which you are holding a fully paid booking you may choose between an alternative trip or a full refund. The company is not responsible for any incidental expenses that you may have incurred as a result of your booking such as visas, vaccinations, non-refundable flights or loss of enjoyment, etc. If the alternative trip chosen is of a lower value than that originally booked then you are entitled to a refund of the price difference. If the alternative tour chosen is of a higher value then you will pay the difference in price.

This trip is run in conjunction with Southern Wilderness New Zealand Limited.

We reserve the right to withdraw any person who in our opinion is likely to endanger themselves or others. We also reserve the right to cancel the trip if we become concerned for any reason for the safety of the group or any individual involved in the walk. A cancellation at short notice due to Women's Own Adventure or Southern Wilderness New Zealand Limited's safety concerns will result in a 50% refund of all monies paid for the intended trip. Incidents that may cause a cancellation of the walk can include but is not exclusive to, any damage to the track which may deem it dangerous or unsafe to continue or commence the walk, any weather event which may cause flooding, dangerous amounts of snow, or any weather activity whatsoever which may pose an unacceptable risk to the guests or staff of Women's Own Adventure or Southern Wilderness New Zealand Limited.

WARNING: Under New Zealand law, it is extremely unlikely that you will be able to sue anyone if you are injured. In addition, New Zealand's accident compensation scheme provides only limited assistance to visitors to New Zealand who are injured. booking amendments

If you wish to change your booking in any way, the following fees will apply:

1. Transfer from one tour to another:
 - Amendment request received by Women's Own Adventure 60 days or more prior to your original tour departure date - AUD\$125 per person per change. A transfer can only be made to a departure date within the current validity.
 - Amendment request received by Women's Own Adventure less than 60 days prior to your original tour departure date - charges as per cancellation fees.
 - If there has been any change in the price of the tour you change your booking to, since the time of your original reservation, the new tour price will apply to the new reservation. These fees are in addition to any charges levied by hotels, ground operators or airlines.
2. Changes to any other arrangements made in conjunction with your tour booking (eg: hotels, transfers, etc.)
 - Amendments to any other arrangements made in conjunction with your tour reservation will incur a AUD\$50 administration fee per booking per change. This fee is in addition to any charges levied by hotels, ground operators or airlines.
3. No amendments are permitted to your booking within 10 days of departure.

late bookings

For bookings made within 15 days of departure, Women's Own Adventure reserves the right to charge a late booking fee of AUD\$50 per booking. On some trips it is not possible for us to accept late bookings.

insurance

Travel insurance is compulsory for all Women's Own Adventure travellers. Your travel insurance must provide cover against personal accident, medical expenses, emergency repatriation and personal liability.
